What is the Bible

The term “bible” or “biblia” comes from the Koine Greek language, and means “collection of many books”.

Throughout time religious books were gathered and bundled together; such a bundle of books is called a biblia, or bible.

Which bible

The vast majority of the books that were bundled in this way contain the message of God and the knowledge and actions of the people who worked for or against God.

A small number are books that are, due to unknown authorship or other uncertainties, apocryphal; meaning that these books cannot be proven to be authentic.

The necessary conditions for a book to be called authentic are that it must be written during the time of its suggested author, and the message of the book must be in line with other authentic books.

The apocryphal books were a reason for the protest of a large group of Christians, (the Protestants) who then excluded these books from their bundle. However, the Catholic church kept the apocryphal books in their bundle, and thus two bundles, or Bibles, were accessible.

The Catholic church has bundled together 73 books, including the apocryphal books.

The Protestant church has bundled together 66 books, excluding the apocryphal books.

Nonetheless, the authentic prophetic books such as the Gospels and the Prophets are in both the Catholic and Protestant Bibles.

Added to the prophetic books are the letters (epistles) of the disciples, who provided their understanding of the prophecies and commandments.

Because of the uncertain origins of the apocryphal books within the Catholic Bible, I will continue with the Protestant Bible.

Translation errors

Sending the divine message to humans is God's work and is without error, but writing down, translating and copying the divine message into Aramaic, Greek, English, Arabic or any other language is human work and will thus contain human errors.

When God ordered Moses to write down the Law in order to give copies to each of the twelve tribes of Israel, he knew that, with time, human copying errors could occur, so he ordered the original manuscript of the Law to be kept in the tabernacle, as proof against any false copy.

Deuteronomy 31:26

Take this book of the law, and put it in the side of the Ark of the Covenant of the LORD your God, that it may be there for a witness against thee.

Such errors or fabrications are possible with every copied writing, including the copies of the Biblical books.

God is aware of this and thus gave a fair warning to those who intentionally distort His message.

Revelation 22:19

And if any man shall **take away from the words of the book** of this prophecy, God shall take away his part out of the book of life, and out of the holy city, and from the things which are written in this book.

Deuteronomy 4:2

You shall not add to the word which I command you, **nor take from it**, that you may keep the commandments of the Lord your God which I command you.

According to God, it is possible to distort the Bible, but not without consequences.

Is todays Bible reliable

Since the discovery of an ancient scroll of Isaiah in 1947, we have seen that the main message of the prophetic book of Isaiah has remained the same in the copy of Isaiah we have today, and all the other copies of the authentic books still agree and fulfil each other. Thus we can be confident that the main message of the biblical books we have today are still original messages that came from God.

Our main concern is to be alert for significant translation errors, which are easily discovered when the context of a verse has become illogical, distorted, or contradicts the other books.

Examples of translation errors:

King James bible in 1944:

"Owl" instead of "own"

1 Peter 3:5 read, "For after this manner in the old time the holy women also, who trusted God, adorned themselves, being in subjection to their owl husbands."

King James bible in 1823:

"Camels" instead of "damsels"

Genesis 24:61 read "And Rebecca arose, and her camels, and they rode upon the camels, and followed the man: and the servant took Rebecca and went his way."

But even when through time people added, removed, or mistranslated words from the Bible the original message of God survived and spread worldwide to this day, because there have always been people who were alert and corrected the mistranslations or raised their voices against false teachings.
